

**SUMMARY**  
***of the Organisation (All-Ukrainian Foundation for Children's Rights) Strategy***  
***until 2025***

The current Strategy was approved by the General Assembly of the All-Ukrainian Foundation for Children's Rights" (hereinafter the Organization) in 24 January 2023. The previous Strategy was modified due to the start of a full-scale war in Ukraine and a change in the Organization's priorities.
